Turnfurlong Infant School Governing Body Delegation Planner

Introduction

The Turnfurlong Infant School Governing Body (GB) is accountable in law for all major decisions about the school and its future. However, this does not mean that it is required to carry out all the work itself. Very many of the tasks can and should be delegated to individuals and committees. It is vital that the decision to delegate a task/responsibility to an individual is made by the FGB and recorded – without such a formula, the individual/committee has no power to act.

This planner shows to which level the Turnfurlong Infant School governing body may legally delegate functions. It also records where the NGA does not think that, even if a task/responsibility can be delegated, this would be good practice.

Key

Level 1: Full governing body

Level 2: A committee of the governing body

Level 3: An individual governor

Level 4: Headteacher.

Blue box Function **cannot** be legally carried out at this level.

✓ Action could be undertaken by this level.

✘ Although legally possible to delegate to this level, the NGA would not recommend it. Significant decisions, monitoring and evaluation are best undertaken by the governing body or a committee with delegated authority, not by individuals. As long as it is line with the regulations governing bodies are free to decide for themselves.

- The Turnfurlong Infant School GB is responsible for the strategic direction of the school
- Sub-Committees can be given delegated authority to make decisions, monitor, evaluate and review particular plans, policies and targets. The Head Teacher and staff play the major role in formulating plans, policies and targets to bring to committees or to the governing body for discussion prior to adoption by the full governing body.
- The Head Teacher is responsible for internal organisation, management and control of the school and is accountable to the governing body.
- **Although decisions may be delegated, the Turnfurlong Infant School GB as a whole remains responsible for any decision made under delegation.**
